Re: Request for Pre-filing Review

Spire STL Pipeline

Project Docket No. PF16-_ooo

Dear Ms. Bose:

Spire STL Pipeline LLC ("Spire"), a wholly owned subsidiary of Spire Inc.¹, is proposing to build, own, operate and maintain the Spire STL Pipeline ("Project"). Spire respectfully requests that the Staff of the Federal Energy Regulatory Commission ("Commission") initiate a pre-filing review of the proposed Project pursuant to 18 C.F.R. § 157.21.

Project Overview

As proposed, the Project will serve the energy needs of residential, commercial and industrial customers in the eastern portion of Missouri, including the St. Louis metropolitan area and surrounding counties. Based on current market needs, principally from Laclede Gas Company ("LGC"), approximately 70 percent of the natural gas transported by the Project will be consumed by residential customers for heating and other domestic purposes and 30 percent by commercial and industrial customers for heating and various commercial and industrial applications and other purposes. By providing access to new, favorably priced natural gas supplies, the Project will increase the reliability and security of natural gas supplies in eastern Missouri and provide users in that area with additional opportunities to benefit economically from the access provided by the Project to a more diverse portfolio of gas supply sources.

The purpose of the Project is to meet the needs of the Project's Foundation Shipper, LGC, for (a) an additional source of natural gas to the St. Louis metropolitan area to support LGC's local distribution service obligations to its 647,000 residential, commercial, and industrial customers in Missouri – in particular, to provide LGC with access to cost effective natural gas from the prolific Appalachian Basin, (b) to support earthquake resiliency and enhance physical transport diversity for the region LGC serves,

and (c) to create new commercial and industrial development opportunities in the St. Louis metropolitan area. In addition, the Project will provide energy infrastructure in southwest Illinois that may help support future commercial and industrial growth opportunities and the potential for future residential natural gas service in new franchise areas.

The Project as proposed will consist of approximately 60 miles of new build 24-inch-diameter steel pipeline (referred to as the "new build" portion of the Project) originating at an interconnection with the Rockies Express Pipeline LLC ("REX") pipeline in Scott County, Illinois, extending down through Greene and Jersey Counties in Illinois before crossing the Mississippi River and extending east in St. Charles County, Missouri until crossing the Missouri river and tying into an existing 20-inch-diameter steel transmission pipeline in St. Louis County, Missouri that is currently owned and operated by LGC (referred to as "Line 880"). As part of the proposed Project and subject to LGC's receipt of approval from the Missouri Public Service Commission ("MPSC"), Spire plans to purchase Line 880 from LGC and modify approximately nine miles of existing 20-inch-diameter steel natural gas pipeline located in St. Louis County, Missouri that will connect the new build part of the project to the Enable Mississippi River Transmission, LLC ("MRT") pipeline along the western bank of the Mississippi river in St. Louis County, Missouri. The total length of the entire Project will be approximately 70 miles.

The overall design capacity of the pipeline is expected to be 400,000 dekatherms per day ("Dth/d"). No compression will be required. The Project as proposed will include pipeline interconnects with REX and Panhandle Eastern Pipe Line Company LP ("Panhandle") in Illinois and LGC and MRT in Missouri.

To support this request, Spire provides the following information related to the Project, in accordance with section 157.21 (d) of the Commission's regulations.

(1) A description of the schedule desired for the Project including the expected application filing date and the desired date for Commission approval.

Spire requests approval to commence the pre-filing process on or about July 15, 2016 and plans to file a certificate application on or about six months from the date of the Director of the Office of Energy Project's Notice approving the use of the pre-filing process for this Project ("Director's Notice"). Spire will coordinate with Commission Staff to develop complete Resource Reports. Spire will work with Commission Staff to secure the necessary authorizations that will permit it to meet its planned inservice date of November 1, 2018. To summarize, the proposed Project timeline is as follows:

Spire is seeking to use the pre-filing process to develop and obtain timely processing of its certificate application. Adhering to this timeline will allow for the receipt of all applicable permits and authorizations necessary for Spire to begin pre-construction activities, as well as the orderly mobilization of contractors and materials and the resolution of any outstanding landowner issues. During the pre-filing process Spire will conduct significant outreach efforts to seek stakeholder input, conduct field surveys for cultural resources, wetlands and endangered species to identify and address routing issues, and submit permit applications to federal, state and local regulatory agencies. Spire anticipates resolving issues raised during the scoping process and submitting a complete application to the Commission by January 2017.

Within 30 days of the Director's Notice, Spire will submit a draft of Resource Report 1, a summary of alternatives to be addressed in Resource Report 10, and a list of affected stakeholders to the Commission Staff. Spire also will comply with the timelines established by the Commission and provide Commission Staff the other information as set forth in Section 157.21(f) of the Commission's regulations.

(2) For LNG terminal facilities, a description of the zoning and availability of the proposed site and marine facility location.

No LNG terminal facilities are involved in this Project.

(3) For natural gas facilities other than LNG terminal facilities and related jurisdictional natural gas facilities an explanation of why the prospective applicant is requesting to use the pre-filing process.

The pre-filing process is designed to engage federal, state and local agencies and all stakeholders during the development phase of the Project and is a mechanism to identify and resolve issues at the earliest stages of Project development and help facilitate the planned in-service date of November 1, 2018. The pre-filing process will provide the Project and interested stakeholders the opportunity to discuss and address routing, siting, and other environmental issues with Commission Staff prior to developing and filing the certificate application. It will permit the Project scoping and environmental review processes to proceed concurrently with the final design and route selection for the Project. Involving agencies, landowners and other stakeholders early will result in a more effective and efficient certificate application and subsequent regulatory review. A detailed description of the Project, including location maps and plot plans to scale showing all major plant components, will serve as the initial discussion point for stakeholder review.

Contractual Commitments

The purpose of the Project is to meet the needs of the Project's Foundation Shipper, LGC, for (a) an additional source of natural gas to the St. Louis metropolitan area to support LGC's local distribution service obligations to its 647,000 residential, commercial, and industrial customers in Missouri – in particular, to provide LGC with access to cost effective natural gas from the prolific Appalachian Basin, (b) to support earthquake resiliency and enhance physical transport diversity for the region LGC serves, and (c) to create new commercial and industrial development opportunities in the St. Louis metropolitan area. In addition, the Project will provide energy infrastructure in southwest Illinois that may help support future commercial and industrial growth opportunities and the potential for future residential natural gas service in new franchise areas. Spire is currently negotiating the terms of its Foundation Shipper precedent agreement with LGC, and is planning to hold an Open Season for the Project in August, 2016.

Maps

A map of the Project's proposed route is provided in Exhibit A.

Pipeline

The new build portion of the Project as proposed will consist of approximately 60 miles of 24-inchdiameter steel pipeline originating at an interconnection with REX in Scott County, Illinois, extending down through Greene and Jersey Counties in Illinois before crossing the Mississippi River and extending east in St. Charles County, Missouri until crossing the Missouri river and tying into Line 880, an existing 20-inch-diameter steel transmission feeder pipeline in St. Louis County, Missouri that is currently owned and operated by LGC. As part of the Project, Spire proposes to purchase Line 880 from LGC and modify the pipeline for interstate service. Line 880 consists of approximately nine miles of existing 20-inch-diameter steel natural gas pipeline located in St. Louis County, Missouri that will connect the new build part of the project to MRT along the western bank of the Mississippi river in St. Louis County, Missouri. The modifications of this existing pipeline will include (a) the replacement of syphon drips, (b) replacement of mainline valves, and (c) replacement of an existing stream crossing. No change in MAOP or capacity of Line 880 is presently contemplated. The total length of the entire proposed Project will be approximately 70 miles and will include the construction of minor aboveground facilities including three metering and regulating stations, one standalone regulating station, and two additional metering and regulating stations along Line 880. A pig launcher/receiver will also be installed at each portion of the Project.

The overall design capacity of the new build portion of the pipeline is expected to be 400,000 Dth/d. No compression will be required. The Project as proposed will include pipeline interconnects with REX and Panhandle in Illinois and LGC and MRT in Missouri.

Compression

No compressor stations are currently proposed for the Project.

(4) A list of the relevant federal and state agencies in the Project area with permitting requirements. For LNG terminal facilities, the list shall identify the agency

designated by the governor of the state in which the Project will be located to consult with the Commission regarding state and local safety considerations.

A list of the relevant regulatory agencies in the Project area with permitting requirements for this Project is provided with this letter as Exhibit B. Spire has conducted initial phone conversations and/or in-person meetings with the various federal and state agencies across the Project area and introduced the Project and the pre-filing process. Additionally, formal letters that outline the Project's scope and Spire's intent to use the Commission's pre-filing process will be submitted in July 2016. These letters will invite each agency to participate in the pre-filing process. In addition, Spire began meeting with agencies in June 2016 to introduce and discuss the Project and the applicable procedures and schedules.

Exhibit B includes the agency name, permitting authority, and estimated permitting timeline for each respective agency. The Project expects to file applications for all necessary federal permits concurrent with the filing of the certificate application. Exhibit C provides information for Native American Tribes with potential interest in the Project.

Spire understands that the Commission will be the lead federal agency conducting the environmental review. The Project will coordinate with the Commission Staff as discussions continue with the various regulatory agencies throughout the pre-filing and Certificate review processes.

Include

A statement indicating that those agencies have agreed to participate in the process. §157.21(d)(5)(ii)

Exhibit B contains environmental resource agencies with known jurisdiction over the Project. These agencies were notified of the project and notified of Spire's intent to utilize the pre-filing process. At this time, Spire anticipates that the United States Army Corps of Engineers St. Louis District may be a cooperating agency with the Commission.

A statement indicating how the applicant has accounted for agency schedules for issuance of federal authorizations. §157.21(d)(5)(iii)

Exhibit B contains both the anticipated submittal dates and anticipated receipt dates for these authorizations. These dates fit not only the Commission's overall timeline for National Environmental Policy Act ("NEPA") review, but also permit Spire to meet its proposed construction and in-service schedules.

A statement indicating when the applicant proposes to file with these agencies for their respective permits or other authorizations. §157.21(d)(5)(iv)

Spire anticipates filing for its pre-construction permits concurrently with or shortly after it files its Application for a Certificate of Public Convenience and Necessity with the Commission. Certain state construction permits will be submitted closer to construction. Please refer to Exhibit B for these permits and dates.

(5) A list and description of the interest of other persons and organizations who have been contacted about the project (including contact names and telephone numbers).

A list of stakeholders, other persons, and organizations that have been, or will be, contacted about the Project is attached as Exhibit C. Beginning in May 2016, Spire notified many stakeholders of the Project, including federal, state, local and municipal officials. Within 14 days of the Director's Notice, Spire will contact all stakeholders not already informed about the Project, including any affected landowners (as that term is defined by 18 CFR Section 157.6(d)(2)).

(6) A description of what work has already been done, e.g., contacting stakeholders, agency consultations, project engineering, route planning, environmental and engineering contractor engagement, environmental surveys/studies, and open houses. This description shall also include the identification of the environmental and engineering firms and sub-contractors under contract to develop the project.

Initial Review

Prior to its name change to Spire, The Laclede Group initially developed a new pipeline project route in July 2010. The original route was designed to interconnect with the REX pipeline to bring gas into the St. Louis metropolitan area. Since then, utilizing publically available data, Spire developed a route based on technical, economic and environmental considerations. Spire utilized a Preliminary Pipeline Routing Optimization tool to identify the optimal route that would avoid or minimize routing through forested areas and other environmental constraints and provide co-location opportunities.

Route Selection/Environmental Review

GAI Consultants, Inc. ("GAI") has been retained to complete all biological and cultural surveys and to support Spire in its conduct of the pre-filing process, state and federal permit acquisition, environmental resource report preparation and certificate application prosecution. To date, GAI has conducted preliminary research and desktop analyses of the preferred corridor based on publicly available natural resource information from several geographic information system ("GIS") databases and resources. GAI evaluated the route for wetlands, waterbodies, listed species and public lands in June 2016.

Environmental field surveys will begin in July 2016 pending survey permissions. Spire will provide environmental data in support of any permit, clearance or other authorization. Field surveys will validate the preliminary corridor, provide corridor alternatives, identify a proposed route for the pipeline within those corridors, identify any additional route variations, and identify Project impacts. Spire anticipates concluding environmental surveys in November 2016.

Land and Engineering

Spire has contracted with MDM to provide land support (including determining legal title and refining the database of aerial photography), and Mott MacDonald to provide civil surveys, and pipeline engineering and design required for this Project. In addition, Mott MacDonald will be responsible for various surveys, studies, and drawings needed to support the filing of permit clearances, or other authorizations. Mott MacDonald has evaluated the preliminary route for constructability, crossing, and

horizontal directional drill locations. The Project's civil and environmental surveys are anticipated to commence in July 2016.

Public Outreach and Open Houses

Spire has retained MDM Public Affairs Professional Services to aid in its outreach effort. Within seven days of the Director's Notice, after consultation with Commission Staff, Spire will establish dates and locations for up to five open houses along the proposed pipeline route. The open houses are planned for August 2016. One open house will be held in each of the five counties on the proposed route. All identified landowners and additional stakeholders on the project stakeholder list will receive an open house invitation letter to the open house in their area.

Each open house will be publicly noticed and open to the public. The open houses will have information stations depicting various aspects of the project including:

- Project/company overview;
- Environmental stewardship;
- Mapping/GIS;
- Construction/Engineering;
- Safety/Operations; and
- FERC Role/comments.

Spire will make every effort to provide opportunities for stakeholders and interested parties to learn about the project and provide feedback to the project team.

Consistent with the Commission's desire for early input by potential stakeholders and with the Commission's endorsement of the use of collaborative procedures in developing new pipeline projects, Spire began meeting with key stakeholders across the project area in May of 2016. Spire held informational meetings to provide an overview of the proposed project and solicit input from the offices of the Governors of Illinois and Missouri. Members from the Project team met with members of the MPSC Commission and Staff in Missouri and state legislators in Illinois and Missouri whose districts are in the Project area. Each of the five counties on the proposed route have received informational face to face meetings from Project staff. In addition, congressional district offices for United States Representatives and United States Senators along the route have been visited and given a Project overview. Meetings with Congressional offices in Washington D. C. are forthcoming.

The Project team is continuing to meet with key leaders and stakeholders and will do so throughout the project.

(7) For LNG terminal Projects, proposals for at least three prospective third-party contractors from which Commission staff may make a selection to assist in the preparation of the requisite NEPA document.

No LNG terminal facilities are involved in this Project.

(8) For natural gas facilities other than LNG terminal facilities and related jurisdictional natural gas facilities, proposals for at least three prospective third-party contractors from which Commission staff may make a selection to assist in the preparation of the requisite NEPA document, or a proposal for the submission of an applicant-prepared draft Environmental Assessment as determined during the initial consultation.

Spire issued its Request for Proposal ("RFP") to five third-party contractors to assist in the preparation of the requisite NEPA documents on June 10, 2016. The RFP required that proposals be submitted to the Project on June 22, 2016. The top three proposals were provided for the Commission Staff on June 30, 2016. Within 14 days of the Director's Notice, the Project will execute the contract with the third-party contractor selected by Commission Staff.

(9) Acknowledgement that a complete Environmental Report and complete application are required at the time of filing.

Spire acknowledges that a complete Environmental Report and a complete certificate application for the Project are required, and will be submitted, as required under Section 7(c) of the Natural Gas Act. The Environmental Report to be submitted for the Project will meet all filing requirements in 18 CFR 380, Appendix A, and will include additional information to address relevant, site-specific issues and scoping comments.

(10) A description of a Public Participation Plan which identifies specific tools and actions to facilitate stakeholder communications and public information, including a Project website and a single point of contact. This plan shall also describe how the applicant intends to respond to requests for information from federal and state permitting agencies, including, if applicable, the governor's designated agency for consultation regarding state and local safety considerations with respect to LNG facilities.

Attached is the Public Participation Plan (Exhibit D) for the Project that details communication tools that have been developed and will be used, along with other activities to be undertaken by Spire to facilitate stakeholder communications, assist with early identification and resolution of issues, and disseminate information regarding the Project proposal.

For the reasons stated above, the Project requests that the Commission Staff initiate a pre-filing review of the Spire STL Pipeline Project.

Exhibit A: Project Location Map



I. Introduction

Spire STL Pipeline LLC ("Spire"), a wholly owned subsidiary of Spire Inc., is proposing to build, operate and maintain the Spire STL Pipeline ("Project").

As proposed, the Project will serve the energy needs of residential, commercial and industrial customers in the eastern portion of Missouri, including the St. Louis metropolitan area and surrounding counties. Based on current customer commitments, principally from Laclede Gas Company ("LGC"), approximately 70 percent of the natural gas transported by the Project will be consumed by residential customers for heating and other domestic purposes and 30 percent by commercial and industrial customers for heating and various commercial and industrial applications and other purposes. By providing access to new, favorably priced natural gas supplies, the Project will increase the reliability and security of natural gas supplies in eastern Missouri and provide users in that area with additional opportunities to benefit economically from the access provided by the Project to a more diverse portfolio of gas supply sources.

The Project, if approved, will significantly enhance the reliability of natural gas service into the St. Louis market and create commercial and industrial growth opportunities in southwest Illinois. At the same time, it will provide LGC, its customers and the St. Louis market with greater access to a more diverse portfolio of supply basins – a result that can contribute to both greater reliability and natural gas cost savings. Finally, the Project will provide LGC with additional flexibility to rearrange its mix of gas supply assets in a manner that will enhance the operational quality of its utility services.

The Project is committed to working with landowners, key local leaders, and other project stakeholders to understand and address the interests and concerns the stakeholder may have regarding the Project. The Project plans to work with all applicable landowners, local communities, municipal, county, state, federal leadership, and all appropriate regulatory agencies and non-governmental organizations to ensure that the Project and associated facilities are developed and operated to meet or exceed all safety, environmental, regulatory and legal requirements. This Public Participation Plan (Plan) is the general guide to help achieve that outcome.

Spire is committed to engaging landowners and other stakeholders and seeking input from them. Throughout the siting process and following the proposed completion, the project and company will remain dedicated to working with the communities along the entire length of the route regarding their needs and interests as the facilities are maintained and operated into the future.

This Plan was developed in accordance with the accepted methods and best practices utilized by the industry and the guidelines set forth by the Federal Energy Regulatory Commission (FERC) in the document titled "Suggested Best Practices for Industry Outreach Programs to Stakeholders", released July 2015.

II. The Project

A. Proposed Project Facilities

As proposed, the Project will consist of approximately 60 miles of new build 24-inch-diameter steel pipeline originating at an interconnection with Rockies Express ("REX") pipeline in Scott County, Illinois, extending down through Greene and Jersey Counties in Illinois before crossing the Mississippi river and extending east in St. Charles County, Missouri until crossing the Missouri river and tying into an existing 20-inch-diameter steel transmission feeder pipeline in St. Louis County, Missouri that is currently owned and operated by LGC. In addition, as part of the proposed Project, Spire proposes to

purchase from LGC and upgrade approximately 9 miles of existing 20-inch-diameter steel natural gas pipeline located in St. Louis County, Missouri that will connect the new build part of the project to the Enable Mississippi River Transmission ("MRT") pipeline along the western bank of the Mississippi river in St. Louis County, Missouri. The total length of the entire Project will be approximately 70 miles.

The overall design capacity of the pipeline is expected to be 400,000 dekatherms ("Dth/d"). No compression will be required. The Project as proposed will include pipeline interconnects with the REX and Panhandle Eastern pipelines in Illinois and LGC and MRT in Missouri.

The pipeline will be governed under Section 7c of the Natural Gas Act, which requires a Certificate of Convenience and Necessity from the FERC and other relevant federal and state approvals before construction can commence. Subject to regulatory approvals, the pipeline is expected to be in-service during the fourth quarter of 2018

Stakeholders include, but are not limited to: potentially affected landowners; nearby residents; concerned citizens; elected representatives; federal, state and local government officials; non-governmental organizations (local or national advocacy groups and chambers of commerce, etc.); Native American tribes; community leaders; and the media.

III. Public, Stakeholder, and Agency Participation Plan

This Plan was developed in an effort to establish clear lines of communication with all interested stakeholders from Project inception to completion.

A. Purpose

The purpose of this Plan is to identify key stakeholders and potential concerns related to the proposed Project, to determine and establish appropriate and effective methods of communication with stakeholders, identify responsible parties, document the public consultation process, and adhere to communication protocols. We are committed to seeking out greater involvement from the various affected groups early in the planning stage so that those who are interested may participate in the design of the Project and the decision making process. Our goal is to involve stakeholders to achieve consensus and settlements on mutually acceptable project designs. We believe an early and more collaborative approach will lead to a Project design that will minimize impacts to landowners, communities and the environment, while enabling us to develop more comprehensive applications for submittal to FERC and other agencies.

B. Outreach Plan Goal

We know that stakeholder outreach and public consultation are essential elements of the permitting process and play an important role in the overall successful development of the Project.

We have developed a comprehensive stakeholder list and this Plan. This Plan is built around the fundamental principle that open, honest and proactive communication is simply the right thing to do, and necessary for the sound development of the Project. We strive to be a good neighbor and a good corporate citizen, and believe that every person, organization, and institution that might be affected by the Project has the right to be informed and should have an opportunity to participate in the decisions that might affect them.

The Project team, including land agents, survey crews, and environmental/biological surveyors will participate in Project Ambassador Training. This training includes appropriate communication, participation and documentation practices for interaction with stakeholders.

The Project team will be trained in Project-appropriate research methods with regard to determining property ownership and legal descriptions. They will receive training on landowner negotiations, including effective listening skills. These skills are a fundamental part of the communication process between stakeholder and agent.

Identify all key stakeholders along the proposed pipeline route. While landowners are the most obvious and directly affected stakeholders, many other individuals and organizations along the proposed 70-mile route also have a stake in the Project. Identifying and engaging them is important to the success of the Project.

Establish channels for two-way communication throughout the life of the Project. We realize that effective communication must be two-way. In addition to sharing information, the Project's outreach effort is designed to create a continuing dialogue with stakeholders, from the start of the pre-filing process through construction and restoration. It is also designed to provide stakeholders with a central point of contact to maintain ease of communication and ensure consistency of messaging.

Ask for public input at critical stages of planning. We believe that the Project is a partnership not only with the commercial partners, but with all stakeholders. With that idea in mind, the Project will seek to gain input and ideas from stakeholders during the planning and pre-filing process. This will help identify and address areas of concern.

Keep stakeholders informed throughout the process. Many outreach plans are designed to communicate effectively during early stages of implementation — especially during the approval stage — but then reduce communication during construction. While communication regarding the Project will certainly be heaviest early in the process, we plan to proactively communicate, via website updates and other methods, during all phases of the Project, even after all approvals have been received.

Engage local resources. To gain insight into public perception along the proposed route and to improve the credibility of the Project, we have retained community involvement specialists to

supplement the efforts of employees of the two partner companies. These specialists will arrange community meetings and other necessary meetings between Project staff and stakeholders. Additionally, they will serve as the "eyes and ears" of the Project, helping to identify growing areas of concern, potential issues, and misinformation.

A. Stakeholder Identification

The Project will focus its efforts on reaching the following audiences:

- Local elected officials
- Mayors, city councils, and/or administrators
- County commissioners, county boards and/or county councils
- County and municipal planning organizations
- Zoning boards, etc.
- State elected officials
- State senators (local area staff)
- State congressmen (local area staff)
- Federal elected officials
- U.S. senators (local area staff)
- U.S. congressmen (local area staff)
- Federal, state, and local regulatory agencies
- Landowners
- Economic development agencies/chambers of commerce
- Owners of mineral rights, such as coal companies
- Local law enforcement agencies
- Local media outlets
- Non-governmental organizations
- Community at large

The status of contacts made to-date with Federal and state agencies, local elected officials, and municipal planning agencies can be found in our request to initiate the pre-filing process with the FERC.

Agencies

The Project has conducted initial phone conversations with the various federal and state agencies across the Project area and introduced the Project and the pre-filing process. Additionally, formal letters that outlined the Project's scope of work and intent to use the FERC's pre-filing process will be submitted in July 2016. These letters will invite each agency to participate in the pre-filing process. In addition, Spire began meeting with agencies in June 2016 to further discuss the Project and the applicable procedures and schedules.

We are committed to working with federal, state, and local agencies. In the spirit of two-way engagement, the Project will respond to requests for information from these agencies in a timely manner. During the initial contacts, lines of communication will be established between the agency

personnel and Project staff. This line of communication will be utilized to confirm our understanding of agency requests and to confirm agency receipt of requested information.

Other Stakeholders

Within 14 days of the Director's Notice, the Project will contact all stakeholders not already informed about the Project, including any affected landowners (as that term is defined by 18 CFR Section 157.6(d)(2)). In areas where notifying a larger group may be necessary, we will expand the mailing list to include landowners that may fall outside the requirements stated in 18 CFR Section 157.6(d)(2). Many of these stakeholders have already been contacted, but it is the Project's goal to provide all stakeholders, including those with which we have already been in contact, the same information at the same time. This letter will describe the Project and provide updated information, inform stakeholders of the pre-filing process timeline, and invite them to Community Open Houses.

B. Stakeholder Outreach Activities

The Project will employ the following methods to ensure successful communication and outreach, including:

Stakeholder identification and issues management database/tracking system. After identifying stakeholders, we will develop and maintain a contact management system to track contact with these stakeholders in a manner that helps identify and resolve emerging issues and concerns.

Project Information materials. We will develop messages and materials to inform stakeholders about the Project and to address potential questions and areas of concern. These materials will include, for example:

- A Project Fact sheet
- A Frequently Asked Questions (FAQ) document
- "Standard presentation" information posters and other materials for use at Community Open Houses and other meetings
- Internal Project guidance concerning key messages about the Project to ensure consistency in communication
- Media advisories to announce public meetings
- Newsletters periodically mailed to directly affected landowners along the proposed and alternative routes, as well as other stakeholders, and will be made available online via the Project website.

Keeping the media appropriately informed helps minimize the potential for misunderstanding and allows us to inform all stakeholders while reducing inaccurate information. Messages and materials about the Project will be refined throughout the development stage to contain updated information and to address stakeholder concerns that may arise. In addition, materials will contain the following information:

- Purpose and need of the Project
- General information on Spire STL Pipeline LLC
- Information on the environment and need and reasons for the project
- FERC background information the role of the FERC and other regulatory agencies in the process, and an overview of the pre-filing and filing processes

- Information on construction, including the types and sizes of equipment used
- Information on environmental activities conducted throughout the Project, including preconstruction environmental surveys, measures during construction to minimize impact on environmental resources including agricultural resources, restoration, and post-construction monitoring
- Safety information a discussion of pre- and post-construction safety, and an overview of the safety record of the interstate natural gas pipeline industry
- A Project timeline an intended timeframe for completing key phases of the Project

Training. A significant component of the outreach and communication team's effort is focused on training the Project team. The goal of the training effort is to familiarize all personnel who participate in the Project (including home office, field staff and sub-contractors) of the Plan and to provide specific modules of training. Training will include those developed by INGAA, Interstate Natural Gas Association of America and IRWA, International Right of Way Association, for those personnel and contractors who will interface with the public. Project staff receiving training includes all company personnel and all contractors involved in field engineering, siting and survey, permitting and environmental impact mitigation, land acquisition, operations, property-owner relations, and government affairs. The Project's guiding principle is to train each individual shortly after retention for the Project or before the individual engages in his or her designated role. Additional training will be given on a periodic basis throughout the life of the project to all field personnel serving as an update for project information and a refresher in conduct and purpose of the project.

Website. Because of its accessibility and the ability to be constantly updated, online communications will play a vital role in stakeholder dialogue. In addition to serving as a Project repository for up-to-date materials and information, the Project website will feature mechanisms for stakeholders to ask questions and provide input about the Project. The Project website will contain:

- A narrative and graphic overview of the Project
- Maps of the proposed route
- Downloadable Project fact sheet
- Frequently Asked Questions ("FAQs") and answers, collected during outreach meetings and arranged by topic
- FERC Information, including an overview of FERC's role and where the Project is in the FERC process
- Information on Community Open Houses
- Information on FERC scoping meetings
- Newsroom (Project announcements, press releases, media advisories, newsletter)
- Links to partner company websites, FERC, Office of Pipeline Safety, industry coalitions, state agencies, etc.
- Natural gas pipeline safety information
- Typical pipeline construction sequence
- How natural gas pipelines work

Project newsletters

The above list of materials and contents will be created, added, and maintained based on status of the project and availability of materials.

Direct Contact. The Project will utilize direct contact, either in person, by phone, or correspondence (email and letter) for stakeholders throughout the Project, as appropriate. We will notify landowners affected by the Project as required by FERC's regulations. For example, direct contact by right-of-way representatives is a necessity in communicating with affected landowners. Direct contact with agencies has already been initiated by Project environmental staff and will continue with pre-filing/pre-application agency scoping meetings. The Projects Regulatory and Public Affairs staff will continue the use of direct contact with elected officials (municipal leaders, county commissioners, state and federal senators and key representatives) along the proposed route. Direct contact will allow us to respond in a timely fashion to all inquiries from any agency, federal, state, or local authorities. Other stakeholders, including non-governmental organizations, economic development councils, and the news media will be contacted directly as appropriate to inform those stakeholders of the status of the Project.

Community Open Houses. The Project proposes to conduct 5 Open Houses along the route during the third quarter of 2016 at locations to be determined. These will be in addition to the FERC scoping meetings. A list of tentative dates and locations is provided in the table below. Given the low population density of the Project area, there are few options for meeting locations. These sites were selected based on their proximity to the proposed route and meeting room capacity (additional Open Houses will be held if needed).

Scoping Meetings. FERC may conduct scoping meetings in the Project area, and the Project team may participate in those scoping meetings with the public, as well as with Federal, state and local resource agencies.

C. Community Open House Overview and Format

Stakeholders will be notified and invited, both directly (with invitations sent by U.S. mail) and indirectly (through the media). The meetings have been arranged so that most stakeholders will not need to travel long distances to participate.

A "station" format is the most likely presentation format for the meetings. Stations will be established for different issues, including rights-of-way, environmental, construction, engineering, etc. as well as a

FERC station. Each station will contain information pertinent to that area of project responsibility, presented both in larger visual aids and/or in handout form manned by Project team members knowledgeable of the subject presented. This will allow attendees arriving at different times to circulate among the stations and gather information in a more informal fashion. The information provided to attendees will be basic enough to allow people who are unfamiliar with a project like Spire STL Pipeline, to gain a solid understanding of the parts of the project. Mapping & Alignment Station. The station will be staffed by several Right-of-Way agents knowledgeable with the route and landowners along the proposed corridor. An electronic mapping display using large format LED display monitors connected to the Internet will be used to show interested landowners and stakeholders how the proposed route may affect their individual parcels. Additionally, multiple hardcopies of the maps for the proposed routes will be available for Open House attendees as backups if the Internet or monitors fail.

Project Contact Information. The Project will operate and monitor a toll-free phone number (1-844-885-7234), e-mail address, and postal mailing address that will enable stakeholders to obtain additional project information and provide input. This information will be printed on all materials and included on the Project web site, and will include a single point of contact for stakeholder inquiries.

If deemed necessary, additional community Open Houses or similar public meetings may be held to communicate important information and provide direct communication and dialogue between local stakeholders and Project leadership.

We understand that stakeholder outreach does not stop with the submittal of the FERC application or possible receipt of a Certificate of Public Convenience and Necessity, but is an ongoing commitment to keeping the public at large, affected landowners, the market, and other interested parties informed of the Project status, and will seek to continue the relationships and dialogue built during the crucial early stages of public interaction.

D. Communications Overview

Communications can be described as the exchange of information. The Project is committed to providing and maintaining several vehicles for communicating with all stakeholders identified with the project. These include electronic and print media, along with local meetings on a periodic basis with community groups.
